I acknowledge that I am freely and expressly assuming and accepting any and all risks of property damages, personal injury or death as the user of this equipment and facility.

I understand and am aware that Skiing, Boarding and Tubing are HAZARDOUS ACTIVITIES and that the equipment furnished could be HAZARDOUS to my well-being. I understand that these activities involve a risk of injury to any and all parts of my body. I hereby freely and expressly assume and accept responsibility for any and all risks of injury or death while participating in this activity.

I understand and I am aware that Sapphire Valley Ski Area recommends helmet usage for all Skiers and Boarders, and highly recommends helmet usage for all Skiers and Boarders under the age of 16. Helmets are required for all Sapphire Valley Ski School programs as well as all students participating in freestyle terrain areas, regardless of age.
