I understand and am aware that Tubing is a HAZARDOUS ACTIVITY that the equipment furnished could be HAZARDOUS to my well-being. I understand that these activities involve a risk of injury to any and all parts of my body. I hereby freely and expressly assume and accept responsibility for any and all risks of injury or death while participating in this activity.
